*All written and voicemail public comments received by the Clerk's Office 90 minutes prior to the meeting start time will be forwarded to the meeting body members as correspondence and attached the minutes. All comments received after that time will be forwarded as correspondence the following business day.

DISCLOSURE OF CAMPAIGN CONTRIBUTIONS:

State legislation requires disclosure of campaign contributions of \$250 or more, made to any Planning Commissioner, by any person who actively supports or opposes any application pending before the Planning Commission, and such person has a financial interest in the decision. Active support or opposition includes lobbying a Commissioner and/or testifying for or against such an application. Any person having made a \$250 or larger contribution within the preceding 12 months must disclose that fact during the public hearing or on said application.

The official City Planning Commission policy is that applications pending before this Commission should not be discussed with the Commission members outside of a public hearing. If any representations are made privately, they must be identified and placed in the public record at the time of the hearing.

If you challenge the proposed action in court, you may be limited to raising only those issues you or someone else

raised at the public hearing described in this notice, or in written correspondence delivered to the Planning Commission, at, or prior to, the public hearing.

NOTE: All proceedings before this meeting body are conducted in English. The City of Stockton does not furnish language interpreters and, if one is needed, it shall be the responsibility of the person needing one.

ESTABLISHMENT OF A PLANNING COMMISSION AD HOC COMMITTEE FOR THE FORMULATION OF AN INDUSTRIAL WAREHOUSE ORDINANCE

RECOMMENDATION

It is recommended that the Planning Commission vote to establish a three-member ad hoc committee, to work on the formulation of an industrial warehouse ordinance for the purpose of streamlining and facilitating future discussion before the full Commission.

Summary

On August 10, 2023, the Planning Commission held an informational planning session to gather input on industrial warehouse development measures proposed for incorporation into a new industrial warehouse ordinance. Chair Rizvi requested that an agenda item regarding the establishment of a three-member ad hoc committee of the Planning Commission, to work on the formulation of an industrial warehouse ordinance, be placed on a future meeting agenda.

<u>DISCUSSION</u>

Present Situation

Staff supports the establishment of a three-member ad hoc committee to work on the formulation of the warehouse industrial ordinance, since there are time constraints for presentation of the ordinance to the City Council for consideration by December 31, 2023. An ad hoc committee can streamline and facilitate discussion of the issues before the full Commission. In order to establish the ad hoc committee, a majority vote to approve the resolution is required.

RESOLUTION ESTABLISHING A THREE-MEMBER AD HOC COMMITTEE FOR THE FORMULATION OF AN INDUSTRIAL WAREHOUSE ORDINANCE AND APPOINTING COMMISSIONERS TO SERVE ON THE COMMITTEE

On August 10, 2023, the Planning Commission held an informational planning session to gather input on industrial warehouse development measures proposed for incorporation into a new industrial warehouse ordinance; and

At this meeting the Planning Commission expressed its desire to establish a threemember ad hoc committee to serve in an advisory capacity and review progress on the efforts toward formulation of a new industrial warehouse ordinance that would establish new zoning standards within the City; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STOCKTON, AS FOLLOWS:

1. This Planning Commission hereby approves the formation of the ad hoc committee on the proposed industrial warehouse ordinance to serve in an advisory capacity and review progress on the efforts toward establishing a new ordinance with the City.

2. The Planning Commission appoints three members to serve on the ad hoc committee on the proposed industrial warehouse ordinance. These members will serve on the committee effective immediately and until such time as the industrial warehouse ordinance is presented to the City Council for consideration of approval or until their respective term on the Commission has expired, whichever occurs first.

3. The ad hoc committee on the proposed ordinance will report its progress to the full Commission at the discretion of the Chair.
